Cosmetology license renewal in Washington is required every 2 years on the date of your license issuance. The cost to renew a beauty practitioner's license or an instructor s license is \$55 prior to expiration, or \$110 if you renew past the expiration date.

Whenever a licensed cosmetologist, esthetician, nail technician, hair braider, or barber practices cosmetology, esthetics, nail technology, hair braiding, or barbering outside of or away from the cosmetologist's, esthetician's, nail technician's, hair braider's, or barber's principal office, place of business, or place of employment, the cosmetologist, esthetician, nail technician, hair braider, or barber shall provide any person so requesting proof that he or she has a valid license issued ...

You'll start by braiding the natural hair, and incorporate sections of synthetic hair so that they blend seamlessly together. When box braiding hair, you'll need to apply leave in conditioner to make the hair easier to manipulate.

It is further unlawful for any person to teach in any cosmetology, esthetics, nail technology, hair braiding, or barber college or school approved by the Department or hold himself or herself out as a cosmetology, esthetics, hair braiding, nail technology, or barber teacher without a license as a teacher, issued by the Department or as a cosmetology clinic teacher without a license as a cosmetology clinic teacher issued by the Department.

2. What is natural hair braiding? Natural hair braiding includes braiding a person's hair, trimming hair extensions as applicable to the braiding process, and attaching commercial hair by braiding and without the use of chemicals or adhesives. As of June 8, 2015, natural hair braiding no longer requires a license or certificate to perform or teach.

Section 1175.1300 BarberShop or Cosmetology, Nail Technology, Hair Braiding or Esthetics SalonCertificate of Registration. a) Pursuant to Article IIID of the Act, all cosmetology, nail technology, hair braiding or esthetics salons and barber shops shall obtain a certificate of registration from the Division in order to operate in Illinois.
