Even the most experienced writers have a problem remembering the proper punctuation for certain types of titles. Books are italicized (or underlined) and articles are put in quotation marks. That's about as far as many people can remember.

### When to Punctuate Titles in Italics or Quotes

Including Book Chapters in the Body of Your Writing Titles of book chapters are always enclosed in quotation marks. This is true for any work that is part of a larger work, and chapters are part of the larger work of a book. The chapter title is put in quotation marks, while the title of the book is italicized.

### How to Document Chapters in Books Using an MLA Format ...

Italicize the title of a self-contained whole (e.g. a book, film, journal, or website). Use quotation marks around the title if it is part of a larger work (e.g. a chapter of a book, an article in a journal, or a page on a website). All major words in a title are capitalized. The same format is used in Works Cited list and in the text itself.

### MLA Titles | How to Format and Capitalize Source Titles

Prior to computers, people were taught to underline titles of books and plays and to surround chapters, articles, songs, and other shorter works in quotation marks.

### Titles of Books, Plays, Articles, etc.: Underline? Italics ...

Put the title in quotation marks. Quotation marks enclose titles of smaller works or parts of a whole. Set the title off from the rest of the writing with italic or underlining. By using italic or underlining, you set off titles of larger works or complete works.

### When to Put Titles in Quotation Marks - dummies

In Book Titles, capitalize all major words (Do not capitalize the, an, a, in, for, or but, unless this word begins the title.) and put in italics.
